#### 2.3 Supervising the Board of Management (BOM) by the BOD

The BOD has supervised the BOM in properly performing its functions and duties compliance with the provisions of law, Nam A Bank's Charter, Regulation on Corporate Governance and Regulation on the Operations of the Board of Directors as follows:

- Directing and supervising the implementation of Resolutions, Decisions of GMS, BOD; supervising risk management and the BOM to achieve outstanding results, while ensuring transparency and creating favorable conditions for Shareholders, Investors and State management agencies to effectively perform their functions of supervision, inspection and management.
- Supervising the BOM implementing the orientation of the bank's restructuring plan for the 2021 - 2025 period with the approval of the State Bank of Vietnam, which has drastically improved credit quality and step-by-step optimized asset portfolios, increased profitability.
- Establishing a mechanism for quarterly meetings with the BOM and other management directors (if any) to evaluate the operating situation, promptly direct and resolve the issues under the authority of the BOD to facilitate the smooth functioning of the BOM and the successful achievement of its business objectives.

#### 2.4 Activities of sub-committees under the BOD:

The sub-committees under the BOD includes: Human Resources Committee and Risk Management Committee. These sub-committees operating in accordance with the provisions of the BOD's regulations, researching and advising the BOD on matters under their competence, related to the governance and operations, specifically as follows:

- Human Resources Committee (HRMC): including members assigned by the BOD, advising the BOD on issues related to organizational structure, human resources management under the authority of the BOD with outstanding activities in the first 6 months of 2025 as follows:
  - (i) Participate in consulting on the orientation of Nam A Bank's organizational and operational model, as a basis for adjusting the organizational structure in accordance with the conditions and business needs in each period;
  - (ii) Advise strategic planning and supervise the planning and implementation of human resources management strategies and remuneration policy for the employees of Nam A Bank and its subsidiaries in accordance with the business development orientation of Nam A Bank;
  - (iii) Review and evaluate the adequacy and effectiveness of Nam A Bank's current Human Resources Management Regulations, Procedures, Rules and Policies; Propose necessary improvement solutions;
  - (iv) Advise the BOD on the recruitment, appointment, reappointment, and dismissal of the management directors according to the regulations of Nam A Bank and its subsidiaries based on the proposal of Nam A Bank's Chief Executive Officer and/or the Chairman of the subsidiaries.
- Risk Management Committee: perform the role of helping the BOD to monitor and manage risks during operations to ensure compliance with the provisions of the law, to best serve the objectives of safe and effective business operations in the first 6 months of 2025, specifically as follows:

- (i) Strictly supervise risks related to information technology, cybersecurity, digital technology, and fraud, in order to ensure that the objective of developing a "digital bank" is achieved in a safe and sustainable manner;
- (ii) Advise the BOD on the implementation of a risk management framwork at Nam A Bank, integrating environmental, social, and corporate governance (ESG) risk factors. Supervise the development of ESG risk management policies at Nam A Bank;
- (iii) Review and evaluate the appropriateness and effectiveness of policies, regulations, and rules on risk management at Nam A Bank; recommend timely adjustments and modifications to the BOD where necessary;
- (iv) Analyze and identify early warnings signs regarding Nam A Bank's safety levels against potential and existing risks that may affect operations, and propose preventive measures to minimize risks in both the short and long term.
